The regular meeting of the Town Board of the Town of Garfield was called to order by Chairman Steve Dickinsen, at 6:20 p.m., on Tuesday, March 10, 2009 at the Garfield Town Hall. Full board present. Meeting notice verified.

Ardy Robertson read the minutes of the February 4, 2009 meeting. Motion by Lamoine Hanson, seconded by Bob Rindahl, to approve minutes. Motion carried.

Treasurer's report of income and expenses for February, 2009 was given by Lori Prudlick. Motion by Bob Rindahl, seconded by Lamoine Hanson, to accept report as presented. Motion carried.

Bills were presented for payment. Motion by Lamoine Hanson, seconded by Bob Rindahl, to approve payment of same. Motion carried.

Jackson County Board of Supervisors member Karen Thayer was present. She reported the board is actively working to fill the vacant Highway Commissioner post, and is considering some sort of job sharing arrangement with Clark County.

Discussion on possibility of purchasing land adjacent to town hall or shop. It was decided to invite Carl Peterson to the next town meeting to discuss possible land purchase.

ROADS & BRIDGES: Jackson County has notified us they plan to put up the seasonal weight restrictions as of March 13th. Motion by Lamoine Hanson, seconded by Bob Rindahl, to post township road bans to coincide with county. Roads included are Sand Lane, Sperber Road, Bluff View, Old 10, Price Road, Old 17, and Rindahl Valley Road. Motion carried.

The Township Road Improvement Project (TRIP) on Bluff View is ready for bidding. Motion to authorize Fleming, Andre, and Associates (Engineers) to let bids made by Bob Rindahl, seconded by Lamoine Hanson. Motion carried. Fleming, Andre and Associates will handle the advertising for bids and the bid documents, however clerk will publish a shortened version of same in the local paper of record (Tri-County News).

A town officials workshop is scheduled for May 19th from 8 a.m. to 3 p.m. in Eau Claire

OPERATOR'S LICENSE: Trails' End made application for five operator license renewals, including: Karen Jean Stensen, Paula J. Ross, Steven Lee Perry, Zachary Todd Faldet, and Kayla Jean Faldet; and one new operator license for Amy S. Allard. Motion to approve all six licenses made by Lamoine Hanson, seconded by Bob Rindahl. Motion carried.

Next town meeting is set for Thursday, April 9, 2009 at 6:30 p.m. — this meeting will include the TRIP project bid opening. May meeting is set for May 13, 2009.
